Dear Widener Law Students:

With the fall semester well underway, we can expect a return of the seasonal flu virus as well as potential cases of the H1N1 virus (swine flu). H1N1 is likely to intermingle with seasonal flu throughout the 2009-2010 academic year. The university has been closely tracking the H1N1 virus over the summer, and with your help, we can minimize the impact of this virus and the seasonal flu strain on our university community.

The most important tool in combating the flu in all of its forms is proper hygiene techniques including hand-washing and coughing etiquette. Hand sanitizing stations will be placed in food service areas and other high traffic areas. Please follow preventative guidelines and you will do your part to reduce the spread of illness.

All students are encouraged to consider the seasonal flu vaccine (flu shot). Seasonal flu vaccines will be available at Student Health Services in Chester beginning the third week of September. All Widener students, regardless of what campus they are from, are welcome to receive a flu shot on the Main Campus. Students can also check with their primary caregiver and local pharmacies concerning flu shot availability. When the H1N1 vaccine becomes available later in the fall, it is anticipated that it will be administered on campus to eligible (based on criteria established by the Centers for Disease Control) students at no charge.

The Centers for Disease Control (CDC) has issued guidelines for students who are exhibiting flu-like symptoms. Students should seek medical care if necessary and should not attend classes or public gatherings while ill. The CDC recommends isolation until at least 24 hours after fever has subsided without the help of ever-reducing drugs. If possible, symptomatic residential students are encouraged to return home to recover. If you will be unable to leave campus in the event you become ill, please contact Chris Burrell in campus services to put yourself on a "flu buddy" list with another student to ensure that you have assistance if you become ill.

If you are ill, please call or e-mail your professors if you wish to notify them of your illness-do not notify them in person. They will work with you on a plan to make up for lost class time and assignments you may miss due to illness. If you are concerned about having missed too many classes, please contact your advisor in the Office of Student Affairs.

The university will continue to provide updates on the seasonal flu virus and the H1N1 virus as the academic year progresses. Please monitor the Law School's flu information at <http://blogs.law.widener.edu/preparedness> and on Campus Cruiser.

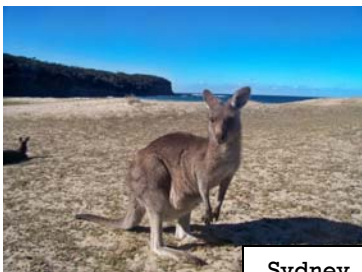
Venice

The AAJ will be hosting a student mock trial competition this Fall. The competition will be held the week of October 19, 2009 in the evening. The trial problem will be a civil case, wrongful death suit. The competition is open to ALL STUDENTS regardless of year, rank or GPA. For first year students who have not had evidence, do not worry, Professor Nivala will be teaching a workshop which will be videotaped for anyone who cannot make it.

The American Association for Justice (AAJ), formerly ATLA, is a national professional organizations comprised mostly of criminal defense and civil plaintiff attorneys. The AAJ's law school chapter program allows students in law schools all over the country to learn and hone their trial advocacy skills through participation in mock trial competitions and an interscholastic competition. Membership in the organization also avails students the opportunity to network with attorneys from all over the nation. Currently two of the AAJ Governors and three past governors are Widener Alumni.

The Competition will be held on:

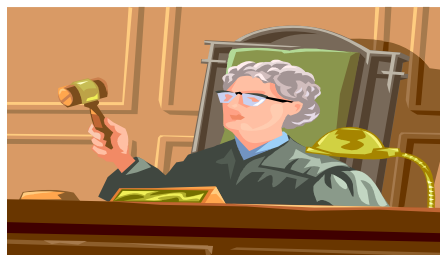
Monday, Wednesday, Thursday, and Friday of the week of October 19, 2009

The Health Law Institute of the Widener University School of Law is excited to announce the Health Law Institute Research Fellowship. The Research Fellow will conduct legal and factual research in support of the health law faculty and the Health Law Institute, and will be expected to devote about ten hours per week to Fellowship-related work during the 2008-2009 academic year. (No assignments will be made or completed during examination periods.)

The Research Fellow will receive \$5,000 for the academic year, payable in regular monthly installments, assuming continuing satisfactory work.

The Widener Law Review (f/k/a the Widener Law Symposium Journal) is the Law School's only general law journal. The Law Review is the result of several years of student, faculty and administration efforts to increase the opportunity for legal publication at the Law School. A faculty committee developed the general framework for the Law Review and selected the first Editorial Board in the Fall of 1993. The Board began organizational efforts in the spring of 1994. The first Symposium was held in March 1995 and publication of the inaugural issue was in May 1996.

Purpose and Process

The (Law Review) is dedicated to publishing scholarship pertaining to current legal issues. Such legal topics are also explored through symposia organized and hosted by the Law Review. Unsolicited articles authored by professors, judges, practitioners, as well as articles solicited from symposia speakers form the core of the Law Review's publication. Student-authored notes, comments, essays, book reviews and other appropriate pieces provide additional material for publication. All submissions undergo the Law Review's rigorous editorial process designed to enhance the overall quality of the authors' work.

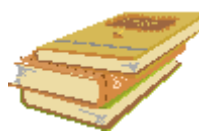

Advice for New Lawyers From a Judge

In an article in the *National Law Journal*, Douglas S. Lavine, a judge on the Appellate Court of Connecticut, gives advice to young lawyers about appearing in court. Most of this advice is basic and self-evident, but Judge Lavine has observed that not knowing how to act in court can put a new attorney at a real disadvantage. This is the first in a series that will share Judge Lavine's 20 points of good courtroom behavior.



1. **Be on time.**
Always plan to get to court well ahead of when the proceeding starts. Lateness is unprofessional and can seriously

inconvenience the court, opposing counsel, witnesses, jurors, and parties. Make allowances for bad weather and heavy traffic, or late buses and subways.

If you are late, always begin your court appearance with an apology and an explanation. For example: "Your Honor, I apologize to the court and attorney Dithers for being late. A tractor-trailer overturned on I-91 and the highway was closed for half an hour."

Full Access to Westlaw and LexisNexis Begins in October for First-Year Students

For the first time on Widener's Delaware campus, full access to the law school versions of Westlaw and LexisNexis will be offered to students in their first semester of law school. Since 2005, first-year students were given passwords and training for limited access in the fall and were given further training and full access at the beginning of the spring semester. Prior to 2005, all first-year students were restricted to researching in the printed versions of reporters and statutes until their second semester. Day students are assigned times for these training classes during the weeks of October 12 and October 19. Evening students can choose the evening classes that suit their schedules during those same weeks. Classes in both Westlaw and Lexis/Nexis are mandatory. Passwords will be cancelled for those students who do not attend training.
