



26th Annual Francis G. Pileggi Distinguished Lecture In Law



Presented by Professor Joseph A. Grundfest Stanford Law School

Professor Grundfest is a nationally prominent expert on capital markets, corporate governance, and securities litigation, and has been recognized as one of the most influential attorneys in the United States. A former chairman of the United States Securities and Exchange Commission, Professor Grundfest also served on the staff of the President's Council of Economic Advisors as counsel and senior economist for legal and regulatory matters, was an associate at Wilmer, Cutler & Pickering, a research associate at the Brookings Institution, and an economist and consultant with the RAND Corporation.

In this lecture, Professor Grundfest examines how forum contests emerge and suggests different ways corporations can address the potential for forum disputes in intracorporate litigation.





More Info. On Hidden Voices

Presentation Description: "Hidden Voices: The Lives of LGBT Muslims" aims to highlight the many struggles and challenges facing sexual and gender minorities within the Muslim world and to examine the complex intersection of Islam, sexuality and gender. With more than 1.5 billion followers Islam is considered to be the fastest growing religion in the world today, yet the Western world continues to view it with skepticism and uncertainty. While aiming to dispel common stereotypes and myths about Islam, this presentation will also explore the history of the queer Muslim movement in the United States and the suppression of LGBT rights around the world under the guise of the so-called "war on terror. Using his own life experience and by exploring the complex history of the Islamic world, "Hidden Voices" strives to bring new light onto the lives of an often invisible and silent community: Muslims who are lesbian, gay, bisexual, transgender, intersex and questioning.



Faisal Alam's Biography: Faisal Alam is a queer-identified Muslim activist of Pakistani descent. At age 19, while trying to reconcile his sexuality with his faith, Faisal organized the first-ever gathering of LGBT Muslims, which led to the founding of Al-Fatiha, an organization for lesbian, gay, bisexual, transgender, intersex & questioning (LGBTIQ) Muslims, and their allies. Faisal led the organization from its inception in 1997 to 2003 as its volunteer director. The mission of Al-Fatiha is to support and empower LGBTIQ Muslims seeking ways to integrate their faith and their sexual orientation or gender identity.

Since founding Al-Fatiha, Faisal has traveled across the country and around the world to meet with LGBTIQ Muslims to build a global queer Muslim movement. Faisal's queer Muslim activism has been featured in LGBT and mainstream media including the *New York Times*, *San Francisco Chronicle*, *BBC World News*, *Al-Hayat*, and the *Washington Post*.

Faisal has received numerous recognitions and awards for his activism on behalf of queer Muslims. The *Advocate Magazine* selected him as an "Innovator," *Genre*

Magazine has recognized him as a "Founding Father," and the *Utne Reader* chose Faisal as one of 30 "Young Visionaries Under 30." In April 2005 the Equality Forum recognized Faisal as one of "40 Heroes" who have "made a defining difference in LGBT civil rights over the last forty years," and in June 2008 Faisal received recognition and an award from Pride Toronto for his "outstanding contribution in the area of spirituality that positively impacts LGBT communities."

RECYCLE

Under **Databases** on the Law Library's home page there is a link to the A to Z Electronic Journal List. By entering the title of a journal, you will be given links to wherever there is an electronic version, from Lexis and Westlaw to ProQuest or EBSCO to HeinOnline or the publisher's own website. Law reviews, other academic journals, or popular magazines may be found through this database. Because of space limitations, many libraries, including Widener, now rely on electronic access to serial publications and keep only the past few years on their shelves, if they subscribe to the print



version at all. Links to online journals can also found in Widener catalog, when the Library subscribes to either the print or electronic version.
