



## **LAUSANNE SUMMER INSTITUTE**

Greetings:

We would like to bring you up to date on Widener's Lausanne Summer Institute. Things are shaping up nicely for an exciting experience. Students who studied with us last summer had a very rewarding cultural and academic experience.

### ***Lausanne***

This will be our sixth year studying at the University of Lausanne's law school in Switzerland. The University of Lausanne is Switzerland's largest university, but the city of Lausanne remains charming and accessible. Lausanne has been the home of the highest Swiss federal court of appeal since 1874, and home to the International Olympic Committee since 1915.



Geneva, a worldwide center of diplomacy and the headquarters of numerous United Nations agencies as well as the International Committee of the Red Cross, is only a 40-minute train ride from Lausanne. Students in the Lausanne program will participate in several field trips in which they will meet and speak with lawyers and policymakers at some of these international organizations.

Because of these many international organizations located in Switzerland, Lausanne is an exciting place to study law. It is also beautiful, situated on Lac Leman (also known as Lake Geneva), with panoramic views of the Alps. Here's what travel writer Rick Steves says about Lausanne: "*Lausanne is the most interesting city on [Lake Geneva], proudly dubbing itself the "Olympic Capital" .... Amble along the serene lakefront promenade, stroll through the three-tiered, colorful old town, explore the sculptures at Olympic Park, and visit the remarkable collection de l'Art Brut*".

### ***New, Condensed Course Format – Extended Division Students Take Note***

June 2 - June 13, 2014 (one credit each)
International Criminal (6/2-6/13/) – Professor Robert Power
Trading In & With Europe (6/2-6/6) – Professor Michael Hahn
Law Practice of the World Trade Org. (6/9-6/13) – Professor Michael Hahn

June 16 – June 27, 2014 (one credit each)
EU Single Market & Regional Trade Issues (6/16-6/27) – Professor Christine Allie
International Investment Law (6/16-6/20) – Professor Andreas Ziegler
International Litigation & Arbitration (6/23-6/27) – Professor Andrea Bonomi

Note that students wishing to travel after the first two-week course segment in Switzerland could then proceed to the first segment of the Venice Summer Institute, which will meet from June 16 to June 27, 2014. Courses offered in Venice will include Comparative Corporate Law, Human Rights Accountability for Multinational Corporations, and European Union Law.
